**SUBSCRIPTION RATES** (effective Sept. 1, 2007)

The current rates of subscription are:

- (i) For Attorneys-At-Law in Private Practice of over 20 years standing - \$7,000 per year;
- (ii) For Attorneys-At-Law in Private Practice of 10 years standing but less than 20 years standing - \$5,500 per year;
- (iii) For Attorneys-at-Law in Private Practice of 5 years standing but less than 10 years standing - \$3,000 per year;
- (iv) For Attorneys-at-Law in Private Practice of less than 5 years standing - \$2,000 per year;
- (v) For Attorneys-at-Law in full time Legal Practice of Government and not permitted Private Practice
  - (a) Of over 20 years standing - \$3,000;
  - (b) Over 10 years standing but less than 20 years standing - \$2,000;
  - (c) Over 5 years standing but less than 10 years standing - \$1,500;
  - (d) Of 0 – 5 years - \$1,000.
- (vi) For Attorneys overseas and not practising in Jamaica US\$50
- (vii) For Attorney-at-Law not in active practice in any manner - \$500.

The above rates are exclusive of 16.5% G.C.T, and are subject to change.

The rates of subscription include a contribution of \$1 to the Association's Benevolent Fund.
