#### 3. NEW LEGISLATION

JAMBAR has received the following Bills from the House of Parliament (Gordon House):

Act No. 5/14 An Act to Amend the Betting, Gaming and Lotteries Act

Act No. 7/14 An Act to validate and confirm as lawful all official acts done by Leon George Thomas, Deputy Mayor of the Municipality of Portmore in good faith, during the period commencing on the 8<sup>th</sup> day of July, 2014 and ending on the date of coming into operation of this Act in the purported exercise of the functions conferred upon him as Mayor of the Municipality of Portmore; to validate and confirm as lawful all decisions and other acts taken and done, in good faith, by the Portmore Municipal Council or any member or committee thereof, in the purported exercise of powers, duties and functions conferred on the Council or any such member or committee by the Municipalities Act, or by any other person by virtue of the purported exercise of such powers, duties or functions, during the period commencing on the 8<sup>th</sup> day of April, 2014 and ending on the date of the coming into operation of this Act; to indemnify Leon George

Thomas, the Portmore Municipal Council and other persons from liability in relation thereto; to amend the Municipalities Act; and for connected matters.

A Joint Select Committee of Parliament has been appointed to review the "Sexual Offences Act" and the "Road Traffic Act".

In considering the Sexual Offences Act, the Joint Select Committee will also review the "Child Care and Protection Act", the "Domestic Violence Act", the "Offences against the Person Act" and the offences and punishment under these Acts placing special emphasis on the protection of the vulnerable (women, children, the elderly and persons living with disabilities) from violence and abuse.

The Joint Select Committee is inviting written submissions from the public to aid the Committee's deliberations. #### 4. OTHER NEWS

- At the Extra-Ordinary General Meeting held on June 28, 2014, Jambar resolved to institute legal proceedings to challenge the Proceeds of Crime (Designated Non-Financial Institution) (Attorney-at-Law) Order 2013. Several eminent counsels volunteered their services, and a legal team has been assembled to handle claim on Jambar's behalf. Members will be asked to make financial contribution to off-set the costs associated with the Court action and any other members who wish to assists in the matter may contact the Jambar Office to make their interest known.
- Miss Casey-Ann Brady, who recently completed her final year at the Norman Manley Law School and will later this year apply to be called as an Attorney-at-Law, has joined the team at the Jamaican Bar Association. During her time at Jambar, Miss Brady will provide administrative and other assistance to the various sub-committees, primarily Continuing Legal Education, Publications and Social Affairs and manage several other projects Jambar is undertaking to better serve our members.
- The post of Public Defender is still vacant. All suitably qualified persons are being reminded to submit applications.
- The Annual Banquet was held on the 18th of July 2014 at the Jamaica Pegasus Hotel. The event was well attended and honourees Justice Hazel Harris, Ms. Nancy Anderson and Lord Anthony Gifford Q.C., received awards and citations.
- The President represented the Bar in the print and electronic media to discuss a number of matters, including the state of our justice system, budgetary allocations to the Ministry of Justice, the poor funding of Legal Aid, the role of Jambar, the Proceeds of Crime Act and the passing of Dennis Daley, Q.C.

These included Power 106, Hot 102, LOOP, the Jamaica Gleaner and the Jamaica Observer.
